

**PENDLETON TOWN COUNCIL
FEBRUARY 1, 2016, 7 PM
REGULAR SESSION**

MINUTES:

After due notice to the press, Mayor and Town Council met in the Council Chambers of Town Hall. Mayor and all Council were present.

1) PLEDGE OF ALLEGIANCE

Mayor Crenshaw led everyone in the Pledge of Allegiance.

2) COUNCIL UPDATES

Mayor Crenshaw referred everyone to the reminders at the bottom of the Agenda.

3) APPROVAL OF MINUTES – January 4, 2016, Regular Session Meeting

4) T. ED GARRISON ARENA UPDATES – CHARLES WILLIAMS

Mr. Williams was present and provided an update of the T. Ed Garrison Arena. He stated the Arena is pursuing upgrades and additions totaling approximately twelve million dollars.

Scott Ward made a motion to table this item until next month. Bruce Kalley seconded. Unanimous.

b. FIRST READING OF THE FOLLOWING:

- i. "AN ORDINANCE TO AMEND ORDINANCES 08-02 & 01-01 AND TO REGULATE THE COLLECTION AND DISPOSAL OF SOLID WASTE, REFUSE, & YARD WASTE WITHIN THE TOWN OF PENDLETON."

Bruce Kalley suggested the word "recycling" be defined and added to the Ordinance.

Bruce Kalley made a motion to accept Ordinance 16-01 for first reading. Scott Ward seconded. Unanimous

- c. REQUEST TO SUPPORT THE SECOND ANNUAL "UNITY IN THE COMMUNITY" TO BE HELD AT VETERANS PARK APRIL 16, 2016, 10 AM TO 2 PM

Scott Ward made a motion for the Town to support "Unity in the Community". Denise Jackson seconded. Unanimous.

- d. A RESOLUTION TO APPROVE THE PATCH DESIGN FOR THE PENDLETON POLICE DEPARTMENT

Scott Ward made a motion to approve the Resolution approving the patch design for the Pendleton Police Department. Denise Jackson seconded. Unanimous.

- e. A RESOLUTION APPROVING A MUTUAL AID AGREEMENT BETWEEN THE PENDLETON POLICE DEPARTMENT AND THE ANDERSON CITY POLICE DEPARTMENT

Bruce Kalley made a motion to approve the Resolution approving the Mutual Aid Agreement between the Pendleton Police Department and the Anderson City Police Department. Scott Ward seconded. Unanimous.

- f. BIDS FOR POLICE VEHICLES

Scott Ward made a motion to reject all bids due to the price versus what was budgeted. Bruce Kalley seconded. Unanimous.
