CONSIDERATION OF FIRST READING OF AN ORDINANCE AMENDING ORDINANCE NO. 16-07 FOR THE TOWN OF PENDLETON, SOUTH CAROLINA AMENDING THE INFRASTRUCTURE AGREEMENT BETWEEN THE TOWN OF PENDLETON AND CLEMSON GROVE INVESTMENTS, PACOLET GROVE HOLDINGS, AND DALTON ROAD HOLDINGS SPECIFICALLY ARTICLE III SECTION 3.01 (e) OF THE INFRASTRUCTURE AGREEMENT
