Michael LeMaiche stated he's a runner and frequent walker in Town. Cherry Street has become dangerous. He asked if Town Council views this as a problem and is there a strategy to address sidewalks and walkability. Mayor Crenshaw stated there was not a current plan. The Town has been working on sewer infrastructure and has prioritized projects and right now that is not one.

Byron Edwards stated he appreciates Carey Fleming bringing up the issue of trucks. He is on the Design Review Board and that intersection is becoming very visible and he thinks it deserves a study.

Amy Albright is curious if there are any ideas of putting a crosswalk at the intersection of Broad and E. Queen Streets. Mayor Crenshaw stated the Town has talked about a 4 way stop at that intersection as well but right now there are no plans for a crosswalk.
