# PENDLETON TOWN COUNCIL REGULAR SESSION JUNE 6, 2016 7 PM

#### MINUTES:

After due notice to the press, Mayor and Town Council met in the Council Chambers of Town Hall. Mayor and all Council were present.

## 1) PLEDGE OF ALLEGIANCE:

Mayor Crenshaw led everyone in the Pledge of Allegiance.

#### 2) COUNCIL UPDATES:

Mayor Crenshaw stated he received an email update from John Sitton, Oil Mill Property Owner. Work is taking place behind the scenes and a lot of the work that is being done cannot be visually seen.

Mayor Crenshaw also stated that he met with Dr. Ronnie Booth of Tri-County Technical College and they will not be contributing any funding towards the C.A.T.bus system.

iii. "A Capital Project Ordinance for the Town of Pendleton Infrastructure Construction Project for The Groves."

iv. "A Capital Project Ordinance for the Town of Pendleton Mechanic Street Streetscape Project." Bruce Kalley made a motion to accept the above Ordinance. Denise Jackson seconded. Unanimous.

## 8) PUBLIC COMMENTS & QUESTIONS.

Mr. John Johnson commented on a brush pile asking if it was collusion, corruption, ethical manner, favoritism, biased, pay back, social control, fairness or justice, it has been over 60 days and asks why the brush is still at the two churches in his neighborhood. The Ordinance doesn't allow this, why are they allowed? Steve Miller stated that the work was completed by the Pastor of the two churches who has a full time job. (Ambassadors for Christ) The Town has talked to the Pastor about removing the brush pile. The Pastor asked if the Town could help and was told the Town could not. The Pastor said they would need time to be able to get it cleaned and the Town told them that was fine as long as they kept in contact with us. Mr. Johnson gave each Councilmember a copy of the Town's Ordinance that regulates clearing lots.

Mr. Charles McCullough commented about Depot Street being closed for the past 4 years. He stated it is a safety hazard especially if a train comes or has to stop in their area. Emergency vehicles could not get through to the other side of the street. He handed out a petition signed by 33 people. Steve Miller, Administrator stated Jo Moss with Anderson County Roads and Bridges performed work using funds from the Town's Roads and Bridges account with the County. If an emergency vehicle had to access the residents, the emergency vehicle would be able to. The needed repairs will cost more than Council has set aside for the work.

Denise Jackson made a motion to adjourn at 7:31 pm. Sandra Gantt seconded. Unanimous.
