

**PENDLETON TOWN COUNCIL  
MAY 2, 2016, 7 PM  
REGULAR SESSION & BUDGET PUBLIC HEARING**

**MINUTES:**

After due notice to the press, Mayor and Town Council met in the Council Chambers of Town Hall. Mayor and all Council were present.

**1) PLEDGE OF ALLEGIANCE**

Mayor Crenshaw led everyone in the Pledge of Allegiance.

**2) COUNCIL UPDATES**

Mayor Crenshaw stated he received an update email from John Sitton, owner of the Oil Mill Property. He stated the agreement with the current contractor has worked out and they should resume clean-up of the property. He further stated demolition should start immediately.

**3) APPROVAL OF MINUTES** – April 4, 2016, Regular Session Meeting & April 25, 2016, Called Meeting  
Scott Ward made a motion to accept the above minutes. Sandra Gantt seconded. Unanimous.

**4) REVIEW & ACCEPTANCE OF THE JUNE 30, 2015 AUDITED FINANCIAL STATEMENTS FOR THE TOWN OF PENDLETON** – McKinley, Cooper & Co., LLC

Marcie with McKinley, Cooper & Co., LLC gave an overview of the Town's Audit for FY ending June 30, 2015. The town received a clean opinion from the auditors.

**5) PUBLIC HEARING TO RECEIVE CITIZEN INPUT ON THE TOWN OF PENDLETON'S FY 2016/2017 BUDGET**
