# PENDLETON TOWN COUNCIL OCTOBER 3, 2016, 7 PM REGULAR SESSION MINUTES:

3) APPROVAL OF MINUTES – September 6, 2016, Regular Session Meeting. Sandra Gantt made a motion to accept the above minutes. Bruce Kalley seconded. Unanimous.

a. REQUEST TO ANNEX AND FIRST READING OF THE FOLLOWING:

i. "AN ORDINANCE TO CHANGE THE CORPORATE LIMITS AND ANNEX APPROXIMATELY .280 OF AN ACRE INTO THE TOWN OF PENDLETON, SOUTH CAROLINA AND DEFINE TEMPORARY ZONING CLASSIFICATION." (LIN GARDENS PROPERTY ON HWY. 76)

Scott Ward made a motion to accept the request to annex and to hold first reading of Ordinance 16-24. Sandra Gantt seconded. Unanimous.

- b. SECOND AND FINAL READING OF THE FOLLOWING:
  - i. "AN ORDINANCE TO CHANGE THE CORPORATE LIMITS AND ANNEX APPROXIMATELY 1.75 ACRES INTO THE TOWN OF PENDLETON, SOUTH CAROLINA AND DEFINE TEMPORARY ZONING CLASSIFICATION" (1012 CHERRY STREET EXTENSION)

Denise Jackson made a motion to accept Ordinance 16-23 for second and final reading. Bruce Kalley seconded. Unanimous.

c. **RESOLUTIONS**:

i. A RESOLUTION OF THE PENDLETON TOWN COUNCIL PRIORITIZING PAVEMENT REHABILITATION IMPROVEMENTS OF ROADS THROUGHOUT TOWN TO BE FUNDED BY ANDERSON COUNTY TRANSPORTATION C FUNDS

Bruce Kalley made a motion to accept the above Resolution. Sandra Gantt seconded. Unanimous.

Scott Ward stated at the top of Micasa Drive, that belongs to the State, there is a low spot where a pot hole pops up every 6 weeks. He believes the first 20 feet needs to be sloped to allow water to drain to prevent the pot hole from continuously coming back.

ii. A RESOLUTION OF THE PENDLETON TOWN COUNCIL AUTHORIZING THE MAYOR AND ADMINISTRATOR TO NEGOTIATE THE PURCHASE OF PROPERTY IN PENDLETON, SOUTH CAROLINA

Sandra Gantt made a motion to accept the above Resolution. Denise Jackson seconded. Unanimous.

iii. A RESOLUTION COMMITTING THE TOWN OF PENDLETON TO PROVIDING A LOCAL MATCH FOR A MUNICIPAL ASSOCIATION OF SC HOMETOWN ECONOMIC DEVELOPMENT GRANT

Bruce Kalley made a motion to accept the above Resolution. Sandra Gantt seconded. Unanimous.

d. REQUEST WAIVER OF LIABILITY INSURANCE REQUIREMENT FOR TRUNK OR TREAT EVENT – John Stone, Masonic Lodge

Scott Ward made a motion to grant the above request. Bruce Kalley seconded. Unanimous.

#### **10) PUBLIC COMMENTS & QUESTIONS.**

*Mike Brown* stated we have a situation at Maple Terrace Apartments and the landlord does not care who he is renting to. There are residents scared to death to live there. He can't let his grandkids play in his front yard scared they will be victims of a drive by shooting. We need to have in place a policy or law that says, Mr. Landlord, if you bring in people who cause trouble and don't do anything about it we are going to hold you accountable. He further stated the Landlord should be responsible for their tenant's behavior.

*Jeff Bennett* stated he does not live in town nor own a business in town but he hopes that will change. Mayor Crenshaw told Mr. Bennett unless he was a resident or a property or business owner in town, he could not speak and would need to contact him or the Administrator.
