Lou Robinson stated based on the rezoning, please do something so it doesn't set a precedent on others wanting to rezone.

Vince Gaulin stated he was here to give an update on Ward 3, specifically related to the demolition project at 216 W. Queen Street. Stating the comments he has received have been positive. Ted Mauro asked for an update on the Fire House placement and what has happened with that. Mayor Crenshaw stated nothing that he knows of. Further stating the Town will become more involved with it as it progresses in order to meet the funding requirements.
