MINUTES:

After due notice to the press, Mayor and Town Council met in the Council Chambers of Town Hall. Mayor and all Council were present.

1) PLEDGE OF ALLEGIANCE

e. CONSIDERATION OF A RESOLUTION FOR THE PENDLETON TOWN COUNCIL TO APPROVE THE BED AND BREAKFAST OWNED AND OPERATED BY MAGGIE & TANNER COOMBS

Scott Ward asked if a B&B always has to have the resident there. Steve Miller, Town Administrator, stated no, not under the current code. Scott Ward made a motion to accept the above Resolution. Denise Jackson seconded. Unanimous.

f. CONSIDERATION OF A RESOLUTION TO THE PENDLETON TOWN COUNCIL TO ACCEPT THE RECOMMENDATION FROM THE TOWN'S PLANNING COMMISSION TO ADOPT THE RE-WRITE OF THE TOWN'S ZONING ORDINANCE

Sandra Gantt asked about the food trucks versus boutique trucks as discussed in the Work Session in July. Lance Estep, COG Representative, said you could take food trucks out and address them like the boutiques in an itinerant ordinance. He further stated you typically see food more often and therefore see them more outlined in Zoning Ordinances. Sandra Gantt asked staff to move forward with amending the business license ordinance to include itinerant businesses.

Sandra Gantt made a motion to accept the above Resolution. Denise Jackson seconded. Unanimous.

8) PUBLIC COMMENTS & QUESTIONS

Nancy von Meyer stated we have to have a Zoning Map. It was stated we have one and just received an updated one. She asked about progress on the Pendleton Oil Mill and any new development. Mayor Crenshaw stated the circuit court judge issued a show cause hearing. She also asked about the old Nicks Café. Steve Miller, Town Administrator, stated we need the IPMC Board put into place to move forward.

Lou Robinson asked about ownership of roads. If we try to own those roads does that mean all maintenance and improvements would be the town's responsibly. Steve Miller, Town Administrator, stated yes. She commented about the heavy trucks and it would be good to monitor them. Lou Robinson also stated thinking about the B&B's is that still operated on a complaint basis and is Mr. Norman Durham still the contact person for those complaints. Mayor Crenshaw stated yes, depending on the complaint.

Scott Ward thanked Amber Barnes for picking out the new banners and thanked the Beautification Committee for paying for them.

Ovaline Williams stated she needs a tree cut down in her yard and is looking for anybody that can help. Mayor Crenshaw stated he would ask around. She thanks our Council and police department for all they are doing.

Sandra Gantt asked about trees falling all over the place and is someone checking them to see if any are near falling. Steve Miller, Town Administrator, stated most likely not.
